



### Part 1: Ensuring Drug Supply Resiliency a multi-prong data driven strategy



Pharmacy staff across PHIs played a critical role in determining sufficient stockpiling of intensive care unit drugs, COVID-19 vaccines and therapeutics based on actual and projected consumption levels and emerging data on COVID-19 treatments.



### **Access to COVID-19 vaccines & therapeutics**

Through HSA's Pandemic Special Access Route, Singapore was able to secure early access to critical novel vaccines, medicines, and medical devices.



To ensure continual and sufficient supply of drugs for treatment of existing diseases as well as COVID-19 therapeutics and vaccines, the team at MOH and ALPS worked closely with pharmaceutical companies, pharmaceutical association and other agencies to source for alternative brands and ramped up warehousing space to accommodate the additional supply.


### Data and guideline driven strategy

A significant number of COVID patients required ICU care due to the severity of their conditions. Given the global shortage of ICU drugs, it was critical for our healthcare institutions to ensure that we had sufficient supplies locally. Tapping on the TTSH experience of treating the first COVID-19 patients and analysing past drug utilization data, Lay Hong and the ICU team at TTSH helped to form the basis of projecting requirements for the national ICU drug stockpile. They also came up with strategies to conserve the limited drug supplies with our nursing and medical teams by using alternatives and minimizing wastage.

"It was stressful preparing for the ICU ramp up and the worry that we would not be able to care for so many patients with the existing number of ICU trained staff."

### Working with limited manpower... Grateful for the support from the ICU team members who did not hesitate when deployed to the Outbreak ICU and carried out their duties to guide the doctors in prescribing optimally for the patients


## Access to COVID-19 vaccines & therapeutics

Under a new regulatory pathway known as the Pandemic Special Access Route (PSAR), which HSA had swiftly implemented in response to the COVID-19 pandemic to expedite access to new COVID-19 vaccines and therapeutics through "interim authorisation", Agnes and her team at HSA were able to evaluate these new vaccines and therapeutics expeditiously while simultaneously applying the same rigorous data-driven evaluation processes, based on the best available scientific knowledge at the time to determine the benefits and risks.

"The regulatory agilities enabled HSA to act quickly in response to an emergency that may pose serious threats to the public and speed up access to critical novel vaccines, therapeutics and medical devices, such as in the situation of the COVID-19 pandemic."

#### Focusing on the science...

The pressure was no doubt tremendous. However, I simply stayed focused on the science and abided by the principle that if I were to approve a vaccine for use by our people, **it must be good enough to go into the arms of my parents and family**.

## Continual supply of medications & vaccines

Hwee San's team at MOH was responsible in ensuring adequate supplies of new COVID-19 vaccines and therapeutics, medical consumables, personal protective equipment and medical equipment for healthcare institutions such that our healthcare system continues to function as per normal. They are also part of the team driving the success of our national COVID-19 vaccination program and ensuring the access to treatments for the C+ cases.

"The management of COVID-19 vaccines required ultra-low storage temperatures of -70°C, making the storage and deployment to vaccination sites, without impacting the efficacy and quality, critical."

When the first C+ case was reported in Singapore, more than 50 MOH officers returned to work on the first day of CNY to review and manage the situation. 

To ensure safe roll-out of COVID-19 vaccines and subsequently, oral anti-virals (OAV) in the polyclinics, Soo Chung and her team worked with the polyclinic teams and various stakeholders to plan the logistics for ordering of vaccines, storage requirements and monitoring of usage due to the short shelf life. The workflow for prescribing the OAV was developed collaboratively with the doctors and a hotline was also extended to participating GPs to help review their patients and answer enquiries regarding OAVs.

"The introduction of oral antivirals like Paxlovid and Molnupiravir, provided an opportunity for the polyclinic pharmacists to play the role in assessing patients' clinical and medication history to identify drug-drug interactions and adjust dosage of chronic medication where necessary."

## Establish, review and refine treatment guidelines



### Imaging suspected and positive COVID-19 cases

The initial months of COVID-19 was fraught with uncertainties and danger but our pharmacy staff demonstrated extraordinary courage by stepping forth to serve suspected and positive COVID-19 cases in our healthcare institutions, dormitories and community care facilities. As the KTPH A&E Pharmacy In-Charge, Ryan was involved in planning the A&E response to pandemic, such as planning workflows for discharge and inflight supply of medication to fever tent and holding areas.

"It was a stressful period as workflows had to keep evolving according to the COVID-19 situation. With limited manpower, our A&E team had to support the patient's needs while fully decked out in PPE for 12 whole hours!"

## Family support during difficult times...

On the first day of Chinese New Year in 2020, I had to meet up with the A&E Nursing team to discuss the medication supply for the fever tent. Hence, after visitation, my entire family, including **my 90 year old grandmother sent me to work**! My grandmother was excited to see the fever tents and cheerfully waved me goodbye! ### Imaging suspected and positive COVID-19 cases

Another pharmacy staff, Norjanah bravely volunteered to work in the NTFGH Emergency Department to counsel and dispense medications to suspected and positive COVID-19 patients.

"One of the biggest challenge was the language barrier with the foreign workers. Despite the difficulty, one of the foreign worker thanked me for my help and assurance. This made me realized how petrified he felt, being in a foreign country during pandemic and being uncertain of what is going to happen. This made me want to contribute more."





### Ensuring continual access to medications **& pharmacy services** Neo Zhi Yang


With the Safe Management Measures in place during COVID-19, patients are advised to stay home and have their medications delivered. Our nimble pharmacy colleagues ramped up medication delivery services (MDS) by 4 times. At SGH, Zhi Yang and his team set up a triage model to screen patients for MDS eligibility by a pharmacist using a specific checklist in order to ramp up the SGH MDS.

"We were able to increase pharmacy operations efficiency due to early upstream identification of prescription-related issues. The successful increase in MDS uptake also allowed virtual healthcare services such as teleconsultation to be adopted hospital wide."

#### Looking after our colleagues...

To minimize unnecessary contact and infection transmission between hospital staff and patients within the pharmacy and bring convenience to our fellow healthcare workers, we also setup a 24-hour secured medication locker service for all healthcare workers working within the Outram Campus to collect their medications.

### Ensuring continual access to medications & pharmacy services

To relieve the hospital bed crunch for COVID-19 patients, the National University Hospital piloted its first COVID-19 virtual ward, which allowed stable patients requiring hospitalisation to be cared for remotely at home. Zhi Xin led the setup of guidelines for the administration and monitoring of COVID-19 therapeutics in home setting, medication review and delivery processes, as well as set up workflows for phone/video counselling.

"As the first hospital to offer home parenteral COVID-19 therapeutics in Singapore, our guidelines were also shared with other hospitals' virtual ward team to speed up their set up process."

## Fulfilling last wishes...

There was a severely ill COVID-19 patient on controlled drugs, whose family would like her to pass on at home. However, the home palliative service could not take on COVID-19 patients, and there were no existing protocols then to allow such patients to be discharged. To **fulfil the family's wish**, the virtual ward team worked to provide care, medication counselling and access to necessary medications. Her daughter was very grateful to our team for allowing the patient to pass on at home with dignity, as opposed to alone in an isolated ward.

### **Educating and empowering patients**

At the start of the pandemic, there were a lot of unfounded rumors related to COVID-19. As the immediate past President, Pei Chean, led the Pharmaceutical Society of Singapore (PSS) to empower and educate the public on COVID-19 prevention and treatment. PSS pharmacists came together to create a hand hygiene and disinfectants guide, which was adopted by MOH as part of their COVID-19 resources. To continue engaging the public despite the pandemic, they pivoted the annual PSS Pharmacy Week carnival online to educate the public on topics such as medication taking tips and medication misinformation.

"We published FAQs to bust the myths of COVID-19 and inform on the updates of COVID-19 vaccination options to help the public understand more on the virus."

### **Educating and empowering patients**


Recognizing that communication was key to medication adherence, Chwee Huat and his team at AH realized that overcoming the language barrier was important to support the teams at the dorms and community care facilities. They worked with volunteers to expand upon the existing translations that other clusters had kindly shared.

"We translated materials such as pictogram labels and counselling placards into 9 different languages to help our Dorm and CCF teams in counselling the migrant workers efficiently and safely in medication taking."

## All hands on deck...

During this period we could witness the kindness, generosity and graciousness from our society and the world got smaller, including that of ex-healthcare professionals including ex-Pharmacists and Pharmacy Technicians. When we asked for help, we got it. Volunteers were more than ready to help in the Dorm Ops as well as the CCFs, this greatly alleviated the bottleneck in healthcare manpower resources.

### Supporting the sharing of health data

Beyond the availing of COVID-19 vaccines, guidance on the inoculation process for patient safety, documentation, and subsequent sharing of immunisation records were critical enablers for Singapore to progressively open our economy and community through vaccination-differentiated SMMs.

Priscilla and her team at IHiS supported the iterative development and deployment of the IT solution for Singapore's COVID-19 Vaccination Programme. Her role included adapting the solution to changes in the prevailing vaccination policies, reviewing healthcare providers' operations and processes, as well as providing onsite tech assistance to their staff. She also implemented the Singapore Drug Dictionary as standardised vaccination codes across all required IT systems for data exchange, enabling deeper health insights.


"These efforts facilitate the sharing of health records and data between national IT systems to ensure that vaccination records are up to date for healthcare professionals to better manage their patients."

They also worked with retail pharmacies to educate and roll out the use of ART kits safely. To date, her team continues to support the management of COVID-19 vaccines and therapeutics.

"Learning from the COVID-19 experience, it's important for us to always be prepared for the next pandemic. We are working towards developing a national drug supply resiliency framework to strengthen our drug supply chain such that our patients will continue to have uninterrupted access to their medications."

New colleagues and friends from PHIs, retail pharmacies, MOH, other Ministries, Statutory Boards, private companies, professional associations, etc went the extra mile to help ensure access and sufficient supplies of relevant drugs and information to empower public.
