*Under VDS, children aged 12 years and below, recovered individuals, and unvaccinated individuals with a valid negative pre-event test (PET) result can be included in the group of 5.

- If there is more than one child aged 12 years and below in the group of 5 persons, all children must be from the same household. An individual aged more than 12 years may sit together with a child from a different household.
- For large-scale events, the number of children is capped at 20% of the actual event size.
