Wedding solemnisations and receptions	<ul style="list-style-type: none"> <li>Wedding couple allowed to unmask only for key moments</li> <li>No dancing or singing allowed</li> </ul>	Wedding couples or individuals from the Wedding Party who (i) undergo an Antigen-Rapid Test (ART) minimally supervised by the venue operator; or (ii) have a valid Pre-Event Test (PET) will be able to enjoy the following provisions:

		<ul style="list-style-type: none"> <li>• Wedding couple will be allowed to unmask throughout the wedding reception or solemnisation while maintaining a safe distance of 2m from other attendees except for the Wedding Party;</li> <li>• Wedding couple will be allowed to dance at wedding receptions, while maintaining a safe distance of 2m from other attendees except for the Wedding Party;</li> <li>• Up to 10 Individuals from the Wedding Party will be allowed to sing and unmask at wedding receptions or solemnisations at external venues, while maintaining a safe distance of 2m from the other attendees when these Individuals are unmasked.</li> </ul> <p>More details will be announced by MSF.</p>

\*Under VDS, children aged 12 years and below, recovered individuals, and unvaccinated individuals with a valid negative pre-event test (PET) result can be included in the group of 5.

- If there is more than one child aged 12 years and below in the group of 5 persons, all children must be from the same household. An individual aged more than 12 years may sit together with a child from a different household.
- For large-scale events, the number of children is capped at 20% of the actual event size.
