### INFECTIOUS DISEASES (COVID-19 — STAY ORDERS) REGULATIONS 2020

#### ARRANGEMENT OF REGULATIONS

##### Regulation

In exercise of the powers conferred by section 73 of the Infectious Diseases Act, the Minister for Health makes the following Regulations:

#### **Citation**

1. These Regulations are the Infectious Diseases (COVID-19 — Stay Orders) Regulations 2020.

#### **Definitions**

2. In these Regulations —

“at-risk individual” means an individual who —

- (a) enters Singapore (by land, sea or air) from a country or territory outside Singapore during the control period;
- (b) before or during the control period, comes into contact or has come into contact with any other individual who is, or is suspected to be, infected with COVID-19;

-

- (c) has, before or during the control period, undergone a test to determine whether he or she is infected with COVID-19 and the test result is pending or uncertain; or
  - (d) at any time during the control period appears to the specified person to be or have been exposed to the risk of becoming infected with or a carrier of COVID-19;

“control period” means the period between 26 March 2020 and 30 April 2020 (both dates inclusive);

“COVID-19” means the infectious disease known as Coronavirus Disease 2019;

“place of accommodation”, for an individual, means —

- (a) the individual’s residence in Singapore; or
- (b) any other place of accommodation of the individual in Singapore;

“specified person” means the Director or any police officer, immigration officer or Health Officer.

### **Stay orders**

3.—(1) A specified person may, for the purpose of preventing the spread of COVID-19, order any at-risk individual to go to a place of accommodation specified in the order and not leave the place of accommodation for a period (not exceeding 14 days) specified in the order.

(2) Any individual who is issued a medical certificate by a medical practitioner with a valid practising certificate, certifying that the individual has acute respiratory symptoms must not leave the individual’s place of accommodation for a period of 5 days starting on the day the medical certificate is issued.

(3) Subject to paragraph (4), an individual who, without reasonable excuse, fails to comply with an order under paragraph (1) or contravenes paragraph (2) shall be guilty of an offence and shall be

liable on conviction to a fine not exceeding \$10,000 or to imprisonment for a term not exceeding 6 months or to both.

(4) To avoid doubt, it is a reasonable excuse if the individual leaves the place of accommodation only to seek medical attention.

(AMENDMENT) REGULATIONS 2020

In exercise of the powers conferred by section 73 of the Infectious Diseases Act, the Minister for Health makes the following Regulations:

**Citation and commencement**

1. These Regulations are the Infectious Diseases (COVID-19 — Stay Orders) (Amendment) Regulations 2020 and come into operation on 27 March 2020.

**Amendment of regulation 3**

2. The Infectious Diseases (COVID-19 — Stay Orders) Regulations 2020 (G.N. No. S 182/2020) are amended by deleting paragraph (4) of regulation 3 and substituting the following paragraph:

“(4) To avoid doubt, it is a reasonable excuse for the purposes of these Regulations if the individual leaves the place of accommodation —

(a) only to seek medical attention; or

(b) with the prior express permission of the Director, whether general or specific.”.

**New regulation 4**

3. The Infectious Diseases (COVID-19 — Stay Orders) Regulations 2020 are amended by inserting, immediately after regulation 3, the following regulation:

**“Stay-home notices**

4.—(1) An individual commits an offence if the individual —

- (a) has, within 14 days before the start of the control period, been given a stay-home notice by a specified person; and
- (b) at any time on or after 27 March 2020 but during the period specified in that notice that lies within the control period, without reasonable excuse, leaves the place of accommodation specified in that notice.

(2) An individual who is guilty of an offence under paragraph (1) shall be liable on conviction to a fine not exceeding \$10,000 and to imprisonment for a term not exceeding 6 months or to both.

(3) In this regulation, “stay-home notice” means a notice that requires the individual to whom the notice is given to stay at and not leave the place of accommodation specified in the notice for the period specified in the notice.”.

In exercise of the powers conferred by section 73 of the Infectious Diseases Act, the Minister for Health makes the following Regulations:

**Citation and commencement**

1. These Regulations are the Infectious Diseases (Composition of Offences) (Amendment) Regulations 2020 and come into operation on 27 March 2020.

**Amendment of regulation 2**

2. Regulation 2 of the Infectious Diseases (Composition of Offences) Regulations 2020 (G.N. No. S 104/2020) is amended by deleting the full-stop at the end of paragraph (b) and substituting a semi-colon, and by inserting immediately thereafter the following paragraphs:

- “(c) any offence under regulation 4(3), 5(4), 6(2) or (3), or 7(4) or (5) of the Infectious Diseases (Measures to Prevent Spread of COVID-19) Regulations 2020 (G.N. No. S xxx/2020);
- (d) any offence under regulation 3(3) or 4(2) of the Infectious Diseases (COVID-19 — Stay Orders) Regulations 2020 (G.N. No. S 182/2020).”.
